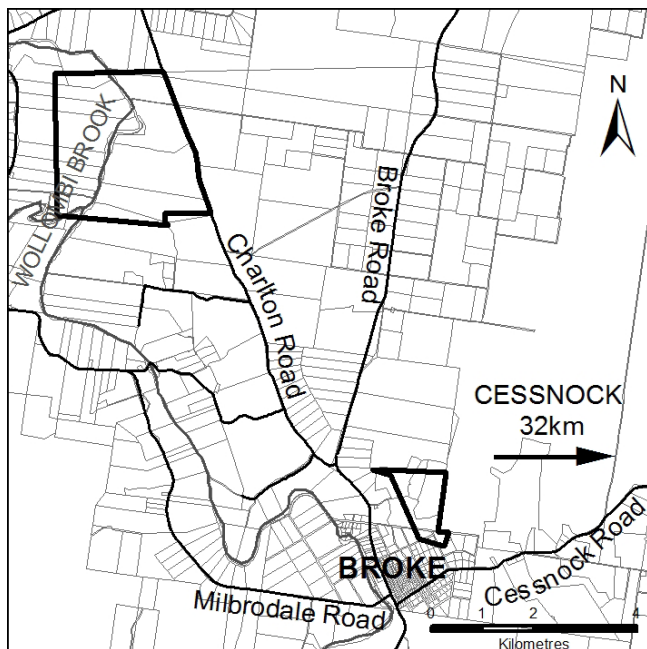

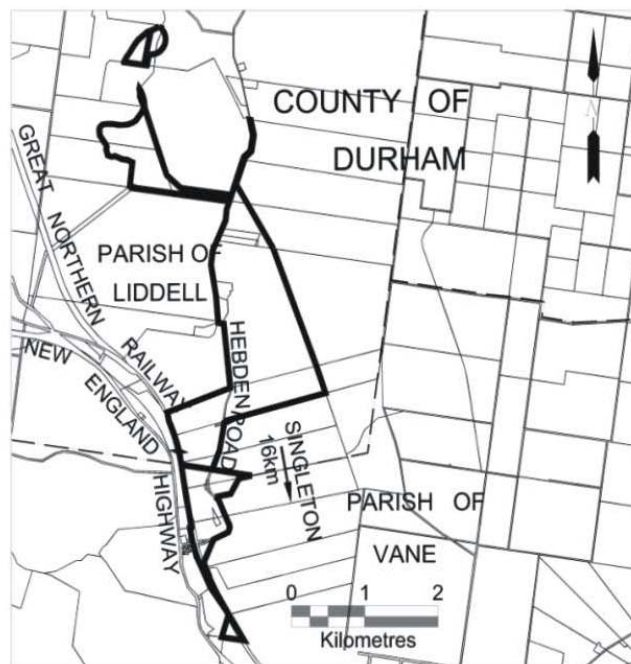

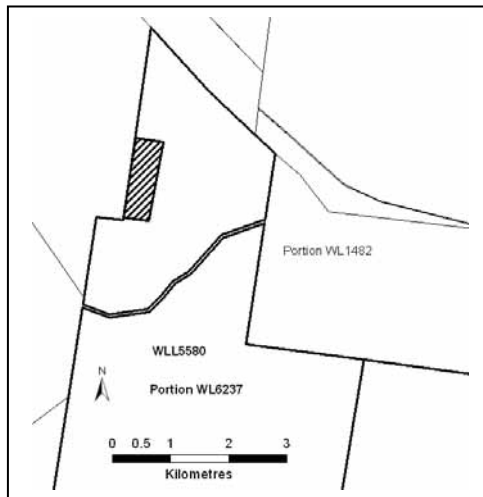

  - contaminated groundwater may migrate further off-site and ultimately impact the Hunter River; and
  - workers may become exposed to vapours during subsurface works at the site.

#### 4. Further action under the Act

The making of this declaration does not prevent the carrying out of voluntary management of the site and any person may submit a voluntary management proposal for the site to the EPA. 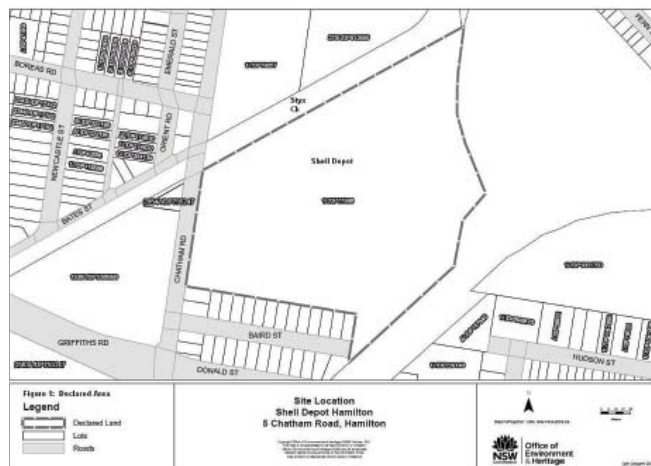

Report and Determination: Commissioner,  
NSW Crime Commission

**REPORT:**

- On 7 March 2012 the Premier, the Hon. Barry O'Farrell, M.P., wrote to the Statutory and Other Offices Remuneration Tribunal ("the Tribunal") advising that the Commissioner, NSW Crime Commissioner, Mr Peter Singleton, had elected to receive remuneration benefits pursuant to section 11A of the Statutory and Other Offices Remuneration Act 1975 ("SOOR Act"). The Premier has approved Mr Singleton's election and nominated the position of Commissioner, NSW Crime Commission (the Commissioner) as one to which section 11A of the Act applies.

**Background:**

- When the SES was introduced in 1989 the Government considered that some Statutory Office Holders, exercising independent functions (excluding judicial officers) should be able to receive employment benefits similar to those provided to the SES. Section 11A of the Act provides that remuneration for such office holders is to be determined on a total cost basis aligned to the SES in lieu of salary. This Group is known collectively as "11A Office Holders" and their remuneration packages are expressed as a total cost of employment.
- Unlike SES officers, the office holders are not subject to contractual employment provisions or performance agreements. In addition, the remuneration of these office holders is expressed as a fixed amount rather than a range as with the normal SES Levels.

**Review:**

- The NSW Crime commission is a statutory corporation established under the New South Wales Crime Commission Act 1985. The statutory objectives of the Commission are to reduce the incidence of illegal drug trafficking and to reduce the incidence of organised and other crime. The Commission also has responsibility for the confiscation of assets of those involved in serious criminal activity. The Commissioner is responsible for the directing and managing the Commission and its resources.
- For remuneration purposes the position of Commissioner is listed in Schedule 1 of the SOOR Act. The Tribunal's determination of 12 October 2011 provides a total remuneration package of \$430,915 for this position. That determination however, was specific to the previous



incumbent who had also elected to receive employment benefits. An election to receive employment benefits and the subsequent determination in respect of a total remuneration package is valid for the current office holder only. On that basis the Tribunal is required to make a new determination to reflect Mr Singleton's election.

6. Having regard to these factors the Tribunal considers that a total remuneration package of \$430,915 would be appropriate and so determines.

**DETERMINATION:**

Pursuant to section 14 (1) of the Statutory and Other Offices Remuneration Act 1975 the Tribunal determines that the total remuneration package for the Commissioner, NSW Crime Commissioner shall be \$430,915 pa with effect from the date of this determination.

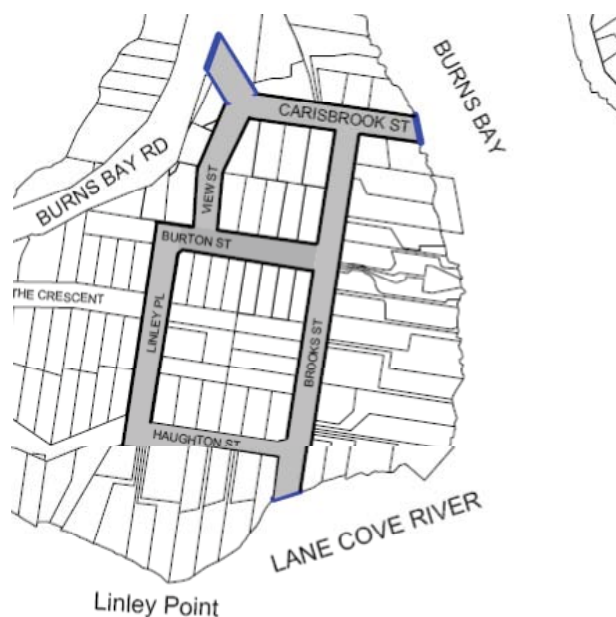

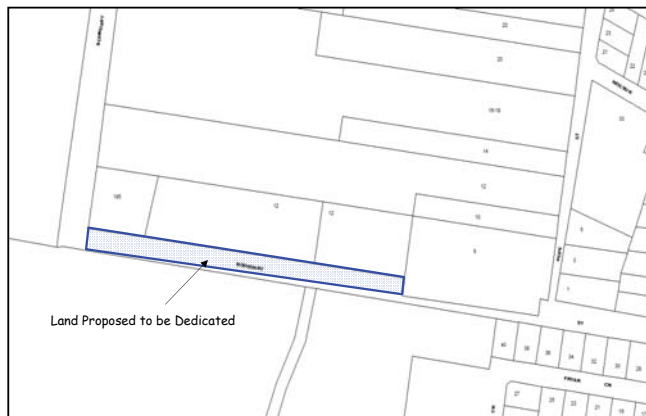
