1. vest \$731,802 of the property of the former Maitland Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in the Cumberland Livestock Health and Pest Authority;
2. vest \$552,863 of the property of the former Maitland Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in the Mid-Coast Livestock Health and Pest Authority;
3. assign the rights and obligations of the former Maitland Rural Lands Protection Board (as existing immediately before the commencement of the

- Amalgamation Proclamation) in respect of the part of the former Maitland Rural Lands Protection District described in Part B of Schedule 3 to the Amalgamation Proclamation which now forms part of the Cumberland Livestock Health and Pest District, to the Cumberland Livestock Health and Pest Authority;
4. assign the rights and obligations of the former Maitland Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in respect of the part of the former Maitland Rural Lands Protection District described in Part A of Schedule 7 to the Amalgamation Proclamation which now forms part of the Mid-Coast Livestock Health and Pest District, to the Mid-Coast Livestock Health and Pest Authority;
  5. assign all of the rights and obligations of the former Maitland Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) not assigned under paragraphs 3 and 4 above, to the Cumberland Livestock Health and Pest Authority and the Mid-Coast Livestock Health and Pest Authority jointly and severally;
  6. vest \$766,885 of the property of the former Molong Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in the Tablelands Livestock Health and Pest Authority;
  7. vest \$540,010 of the property of the former Molong Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in the Central West Livestock Health and Pest Authority;
  8. vest \$163,048 of the property of the former Molong Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in the Lachlan Livestock Health and Pest Authority;
  9. assign the rights and obligations of the former Molong Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in respect of the part of the former Molong Rural Lands Protection District described in Part A of Schedule 13 to the Amalgamation Proclamation which now forms part of the Tablelands Livestock Health and Pest District, to the Tablelands Livestock Health and Pest Authority;
  10. assign the rights and obligations of the former Molong Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in respect of the part of the former Molong Rural Lands Protection District described in Part A of Schedule 2 to the Amalgamation Proclamation which now forms part of the Central West Livestock Health and Pest District, to the Central West Livestock Health and Pest Authority;
  11. assign the rights and obligations of the former Molong Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) in respect of the part of the former Molong Rural Lands Protection District described in Part B of Schedule 6 to the Amalgamation Proclamation which now forms part of the Lachlan Livestock Health and Pest District, to the Lachlan Livestock Health and Pest Authority;
  12. assign all of the rights and obligations of the former Molong Rural Lands Protection Board (as existing immediately before the commencement of the Amalgamation Proclamation) not assigned under paragraphs 9, 10 and 11 above, to the Tablelands Livestock Health and Pest Authority, the Central West Livestock Health and Pest Authority and the Lachlan Livestock Health and Pest Authority jointly and severally.

### Definitions

In this proclamation:

**Amalgamation Proclamation** means the proclamation made under section 5 of the Act titled “Amalgamation of 47 rural lands protection districts to constitute 14 livestock health and pest districts” published in *New South Wales Government Gazette* No. 158 of 19 December 2008 at pages 12876 to 12905.

**former Maitland Rural Lands Protection Board** means the former rural lands protection board constituted under the Act for the former Maitland Rural Lands Protection District.

**former Maitland Rural Lands Protection District** means the former rural lands protection district having the boundaries described under the heading “Maitland” in the proclamation made under the Act titled “Amendment of the Boundaries of Pastures Protection Districts under the Pastures Protection Act 1902” published in *New South Wales Government Gazette* No. 56 of 8 May 1907.

**former Molong Rural Lands Protection Board** means the former rural lands protection board constituted under the Act for the former Molong Rural Lands Protection District.

**former Molong Rural Lands Protection District** means the former rural lands protection district having the boundaries described in the proclamation made under the Act titled “Alteration of Boundaries of Molong Pastures Protection District” published in *New South Wales Government Gazette* No. 172 of 13 December 1985.

**Livestock Health and Pest Authority** means a livestock health and pest authority constituted under the Act for a Livestock Health and Pest District.

**Livestock Health and Pest District** means a livestock health and pest district constituted by or as a consequence of the Amalgamation Proclamation.

This proclamation takes effect on the date it is published in the *New South Wales Government Gazette*.

SECTION 9(1) of the Charitable Trusts Act 1993, permits the application of property cy-pres and administratively where the original trust can no longer be implemented.

In October 1917, Mrs Agnes HOWIE set up, by way of Deed, a trust called the Katoomba Soldiers Home Trust, and appointed the NSW Public Trustee as the trustee. Mrs Howie transferred her two properties at 2 and 4 Goyder Avenue, Katoomba and a small amount of cash to the Public Trustee to be held on trust in perpetuity.

The purpose of the trust was to provide homes for 'needy soldiers who enlisted from Katoomba to fight in the present war [World War I] or future wars for the British Empire...or as homes for the wives, widows, children or dependants of any such soldier'.

In 2008, the NSW Public Trustee (which is now known as the NSW Trustee and Guardian) applied to the Attorney General for a cy pres scheme in respect of the trust, because it considered that for various reasons the trust was no longer viable in its present form. The NSW Trustee and Guardian also wished for the role of trustee to be taken over by RSL LifeCare Ltd ('RSL LifeCare'), which has confirmed that it is prepared to become the trustee of the trust as proposed.

I have formed a view that Katoomba Soldiers Home Trust is a trust for a charitable purpose, being the amelioration of the condition of ex-servicemen and their dependants. I consider that the trust is no longer viable in its present form because of the difficulties involved in carrying out the trust. Accordingly, this is an appropriate matter in which the Attorney General should approve an administrative and cy-pres scheme under section 12 of the Charitable Trusts Act 1993.

I have approved a recommendation that the Attorney General establish a cy-pres scheme pursuant to section 12 of the Charitable Trusts Act 1993 so as to vary the original trust. Pursuant to that section, I hereby order that a scheme be implemented whereby RSL LifeCare be appointed trustee in place of the NSW Trustee and Guardian and whereby the management and administration of the trust property be transferred to RSL LifeCare and which permits RSL LifeCare, cy pres, to rent out the properties according to the following criteria:

- (i) That it first attempts to find war veterans and/or their dependants to rent the homes as short or long term accommodation, with a preference given to such persons who are in financial need and who are from the Katoomba district.
- (ii) If no war veterans and none of their dependants are found to be seeking accommodation then the homes may be rented out for periods of 6-12 months to other persons.
- (iii) In the event a war veteran or any of their dependants requires the use of a home, then, as soon as the 6-12 month lease expires, such cottage would be made available to those persons.

This Order will take effect 21 days after its publication in the *New South Wales Government Gazette*, in accordance with section 16(2) of the Charitable Trusts Act 1993.

3. Section 24A of the Act provides that the Tribunal can make determinations for chief executive office holders listed in Parts 1 and 2 of Schedule 2 of the PSEMA. This office is one such position.
4. Infrastructure NSW is established under the provisions of the Infrastructure NSW Act 2011. The Act outlines the structure, function and obligations of Infrastructure

NSW which include the planning, coordination, selection, funding, implementation, delivery and management of economic and social infrastructure in NSW. Once established, Infrastructure NSW will be required to develop a 20-year State Infrastructure Strategy from which detailed 5 year infrastructure plans will be developed.

5. Infrastructure NSW will play a coordination and facilitation role with other government agencies and the private sector, who will deliver the important projects outlined in the 20-year State Infrastructure Strategy and 5 year Infrastructure Plan.
6. The Act provides for the establishment of a Board which will set the strategic and policy direction for Infrastructure NSW. The Board comprises an independent Chairperson, the CEO, five persons appointed from the private sector, and the Directors General of the Department of Premier and Cabinet, Department of Trade and Investment, Regional Infrastructure and Services, Planning and Infrastructure and the Secretary of NSW Treasury.
7. The CEO will control and manage Infrastructure NSW in accordance with the general policies and strategic direction of the Board. The CEO will lead a group of professionals in an organisation whose structure and functions will create a new model of effective public sector infrastructure planning. The CEO will have the power to second, employ or contract individuals from the private and public for short or long term purposes.
8. The role of the CEO is critical to the successful implementation of the State Infrastructure Strategy. While the overall direction will be set by the Board of Infrastructure NSW it will be the CEO who will need to ensure the successful coordination, progress and delivery of infrastructure projects. To strengthen NSW's strategic coordination capability the office of CEO also assumes the office of Co-ordinator General.
9. In the role of Co-ordinator General, the CEO will be responsible for co-ordinating the input from all State agencies to develop a consistent whole-of-State approach on matters relating to infrastructure, and responsibility for special projects that require statewide coordination.
10. In considering the appropriate level of remuneration payable to this office, the Tribunal has had regard to the importance of Infrastructure NSW in delivering infrastructure projects to NSW, the pivotal role the CEO will play in ensuring their delivery and the additional responsibility associated with the office of Co-ordinator General.
11. Having regard to the above, the Tribunal is of the view that the office of Chief Executive Officer and Co-ordinator General, Infrastructure NSW should receive an annual remuneration package of \$500,000 and so determines.

#### Determination:

Pursuant to section 24D of the Statutory and Other Offices Remuneration Act 1975 the Tribunal determines that the office of Chief Executive Officer and Co-ordinator General shall receive a remuneration package of \$500,000 per annum with effect from the date of appointment.

The Board comprises an independent Chairperson, the CEO, five persons appointed from the private sector, and the Directors General of the Department of Premier and Cabinet, Department of Trade and Investment, Regional Infrastructure and Services, Planning and Infrastructure and the Secretary of NSW Treasury.
5. The establishment of Infrastructure NSW was a key election commitment of the Government. The strategic direction of Infrastructure NSW will be set by the Board who will direct and oversee the preparation of a 20-year State Infrastructure Strategy.
6. Infrastructure NSW will play a coordination and facilitation role with other government agencies and the private sector, who will deliver the important projects outlined in the 20-year State Infrastructure Strategy and 5 year Infrastructure Plan. In addition, Infrastructure NSW will be required, when directed by the Premier, to take responsibility for an entire or specific part of an infrastructure project. Such direction would be limited to those projects of high strategic importance which would benefit from the dedicated focus and expertise of Infrastructure NSW.
7. The Chairperson will play a critical role in ensuring the strategic and policy direction of New South Wales infrastructure is consistent with the 20-year State Infrastructure Strategy. In addition the Chairperson will be required to work closely with government agencies and the private sector to ensure the smooth operation and progress of the state's largest infrastructure projects. As such, the office is pivotal in ensuring the success of Government's most important initiative. The Chairperson will need to have a thorough understanding of, and expertise in both private and public sectors.
8. Having regard to the above, the Tribunal is of the view that the office of Chairperson of the Board of Infrastructure NSW should receive an annual salary of \$70,000 and so determines.

**Determination:**

Pursuant to section 14 of the Statutory and Other Offices Remuneration Act 1975 the Tribunal determines that the Chairperson of the Board of Infrastructure NSW shall receive a salary of \$70,000 per annum with effect from the date of appointment.
